- 1) COUNTY ENGINEER: Dale Foster had no report.
- 2) COUNTY COUNSEL: Jeffrey Lindsay had no report.
- 3) COUNTY TREASURER: Francine Springer had no report.

FREEHOLDER REPORTS:

- 1) FREEHOLDER PIERSON: Freeholder Pierson attended a ribbon-cutting ceremony on February 28th dedicating the new Student Center building on the Mays Landing Campus of Atlantic Cape Community College (A.C.C.C.). It was a nice event highlighting the new space attached to the cafeteria, for people to meet, relax and study he commented.

On March 1st, the freeholder attended the Cape May County Chamber of Commerce sponsored “Women in Business” conference along with Freeholder Hayes. He applauded all the speakers whom he described as fantastic and Susan Adelizzi-Schmidt, for giving a superb presentation, as well as Marie Hayes, who also presented. The event was really well done. Good job he stated.

Mr. Pierson attended a few National Guard Association Meetings to speak with the Veterans, which were very interesting, he noted.

He participated in the New Jersey Office of Homeland Security terrorist truck training with Director Thornton and Freeholder Hayes. The training went well and had a fairly good turnout, although he wished a few more of the municipalities would have been there.

He presented an award at the recent Sea Isle City AARP awards luncheon. This particular award went to a noteworthy person who worked with Veterans and all the other AARP organizations. Freeholders Hayes, Desiderio, Surrogate Marcolongo and Sheriff Nolan attended the event as well.

In keeping with his goal to try to stay in touch with the business associations in the county he attended the Upper Township Business Association meeting. He updated the group on happenings in their area, such as the bridge project, per reports given by the county engineer at caucus meetings.

- 2) FREEHOLDER HAYES: Freeholder Hayes attended a “Drones for Business 101” seminar at A.C.C.C. sponsored by the Cape May County Chamber of Commerce, and a “Women of World War I” presentation given by Pary Tell, which detailed the different type of jobs held by women at that time. International Women’s Day was celebrated on March 8th she informed, which also happened to be her birthday, she added.

She announced that Director of Tourism, Diane Wieland, had secured advertisement for the “Visit the Jersey Cape” campaign, which would air on a Times Square Marquee in New York, located right near *Good Morning America*. Three individual ads, highlighting Cape May County’s assets would be featured. The ads would run 20 hours per day over 108 days she explained and were obtained at a much discounted rate by Diane, who really had proven her worth once again, she stated.

The freeholder reported the County Park & Zoo “Eggstravaganza” would be held Saturday, March 24th from 10:00 a.m. to 2:00 p.m. this year. The main event was an Easter egg hunt, so arrive promptly at 10 o’clock she advised, before all the eggs were gone.

- 3) FREEHOLDER DESIDERIO: As mentioned earlier, during Freeholder Pierson’s report, Freeholder Desiderio attended the AARP awards luncheon in Sea Isle City, to honor local volunteers. Additionally, he participated in a meeting comprised of residents of Strathmere and Sea Isle City, County Engineer Dale Foster and a consultant, to address traffic concerns mainly in the Whale Beach section. The consultant was brought in to go over possible alternatives. Freeholder Morey and Leslie Gimeno, Planning Director attended the meeting too, he reported.
- 4) FREEHOLDER THORNTON: Director Thornton and Freeholder Hayes were present at the Atlantic Cape Community College Board of Trustees Meeting last week, where the FY 2018-19 budget was approved. Security was one of other topics discussed. Cape May County would begin to play a big part in the security on the campus he stated. We’re working on that, he further stated.

As reported earlier, Freeholders Hayes, Pierson and Director Thornton participated in the New Jersey Office of Homeland Security training on the threat of vehicle attacks by terrorists, held in Ocean City. This type of threat had been discussed for some time here already, with the Prosecutor’s Office committee. The lack of business people at the training session was disappointing, he stated. It’s important for people to recognize this type of a threat, because it does exist, and was difficult to control he noted.

He complimented Diane Wieland and the Department of Tourism for participation at the Philadelphia Flower Show, and the impressive amount of work that went into manning the booth. Over 200,000 pieces of literature were distributed over the course of the show. Per Diane, four people worked the booth on Saturday, and had trouble keeping up.

Director Thornton commented on the state of the county after the recent nor'easters; he was ready for them to end. The county was really lucky overall and made out well. There was minimal beach erosion he informed. At one point, 4000 people had lost power, but that quickly dropped to 187

households without electricity, thanks to Atlantic City Electric, who did a wonderful job.
