COMMUNICATIONS: None.

REPORTS:

- 1) COUNTY ENGINEER: Mr. Foster reported that many of the county paving projects were behind schedule because of the rainy weather. Now they were trying to get caught up, paving day and night he stated. The contractor was currently assembling the precast elements on the southern half of the 17th Street Bridge in Ocean City with the bridge being closed temporarily until later tonight. This project was moving right along and scheduled to be completed by the middle of June. The Middle Thorofare Bridge reopened to both lanes of traffic last week. The Railing Replacement Project had been shut down for the summer season he informed. For the Sea Isle Boulevard Bridge, Phase 4 of the Railing Replacement Project still had to be completed. This was the east side of the northbound lane going into Sea Isle City. Plates were going to be installed on the moveable span, the first week of June, causing periodic lane closings on the Townsends Inlet Bridge. The approaches were paved last night on the 34th Street Bridge in Ocean City. Line striping would be done in the morning, as soon as the rain from the previous night dried. In Avalon, the milling and paving would be worked on tomorrow between 29th Street and 44th Streets. They were hoping to get a center line stripe down on that road before the weekend. Broadway in West Cape May was partially milled yesterday. More milling and paving to be done on Wednesday, before finishing up on Thursday night. Bayshore Road in Lower Township had work halted altogether due to the rain and the upcoming holiday weekend. Work on that project would resume again first thing Tuesday morning, May 29th. Indian Trail and Shunpike Roads were being milled and paved this week, some of the paving being done in the overnight hours.
- 2) COUNTY COUNSEL: Jeffrey Lindsay, County Counsel had no report.

3) COUNTY TREASURER: Francine Springer had no report.

FREEHOLDER REPORTS:

1) FREEHOLDER MOREY: Freeholder Morey reported the Everlon building demolition was progressing. Last week, a pre-application meeting was held regarding a grant for a new commercial building on the site, which would feature various technology companies. During the pre-application meeting, the New Jersey Economic Development Authority (EDA) approved full application submittal status for the proposed project, to cost between \$2.5 to \$3 million dollars. The county team has done a great job preparing for the project in collaboration with Lou Joyce of the South Jersey Economic Development District and Triad Associates.

He announced the Coast Guard National Band would be giving a performance on June 8, 2018 at 7:00 p.m. at the Lower Township Regional High School Auditorium. Tickets for the performance must be reserved ahead of time, he noted and Freeholder Hayes confirmed that tickets had to be set aside, people couldn't just show up for the event.

2) FREEHOLDER PIERSON: Freeholder Pierson reported he had attended a meeting recently with the regional director of the Veterans Administration (VA) at the Community Based Outpatient Clinic (CBOC) in Northfield. There are going to be a lot of things happening in the VA community over the next several months, he informed. More information would be provided, as it was too much material to cover right now, he stated.

Pat Devaney, Human Services Director and Freeholder Pierson attended an hour long movie at the Stone Harbor Theatre, followed by a presentation on Resilience Training, intended for students affected by abusive home and school relationships. The training was superb he commented. Faculty and educators in the local school system will also be trained on this issue in the very near future, he stated.

The freeholder attended the Atlantic County Family Support Organization Gala at the Atlantic City Country Club. It was a well-attended and at times very moving event he stated. The presentation consisted of young people relating their stories of abuse taking place in their personal relationships with family or others.

A flag installation took place over the weekend at the Gerald M. Thornton Veterans' Cemetery. Over 70 people participated, which included both Cub and Boy Scouts lending their assistance in the installation of approximately 5600 commemorative flags on the graves. He appreciated the outpouring from the various service organizations like the Elks, etc. that came out.

Both Director Thornton and Freeholder Pierson attended the Armed Forces Day event sponsored by the Cape May Mid Atlantic Center for the Arts. It was held in the Cape May Point State Park Education Building on Saturday, May 19th. The ceremony took place inside due to heavy rainfall.

National Poppy Day would be celebrated this year on Friday, May 25th the freeholder informed everybody present. He urged people to show their support by buying a poppy, which were made by severely injured Veterans, part of their rehabilitation, as a way to keep them involved and active. A portion of the money from the sale of the poppies would stay within the individual organizations.

The City of Wildwood would host a Memorial Day Parade would on Saturday, May 26^{th.} The parade started on Wildwood Avenue, continuing to Andrews and Ocean Avenues, where a candlelight vigil would be held. Many other programs would be held on Memorial Day including the County program at the Gerald M. Thornton Veterans' Cemetery at 2:00 p.m. he further stated.

If raining, the Memorial Day ceremony would be held inside the Cape May County Public Safety Training Center.

3) FREEHOLDER HAYES: Freeholder Hayes announced that the Cape May County Park & Zoo would celebrate its' 40th Anniversary from 11:00 a.m. to 2:00 p.m. on June 9th. A ceremony would kick off the event, followed by zookeeper discussions, introduction of the newest addition to the primate families, the Gibbons apes, bounce houses, steel drums presentation and a magic show. There was something for everyone so come out and enjoy the celebration and family fun she invited.

She witnessed a high elevation rescue response drill at Morey's Piers. The drill was part of training for real life scenario response for possible rescues of persons stuck on rides at the boardwalk piers. It was fascinating to watch the teams working together to accomplish a rescue she commented.

She reported on the efforts of the Board of Chosen Freeholders in collaboration with the Technical School and WIB for a program to have CDL drivers licensed for the purpose of creating a special route with Fare Free Transportation. The plan entailed the drivers picking up employees from the mainland transporting them over to the islands for various job positions during the summer. This was in the works with more information to come as things developed she stated.

The freeholder would once again this year, be participating in a fundraiser for Big Brothers and Big Sisters on June 23rd in Atlantic City. She would rappel down the side of the Sheraton Hotel, from the patio of the penthouse suite, 16 stories high. Donations would be appreciated she stated and could be made on-line at the Big Brothers and Big Sisters website. The fundraiser could be found under the project title, "Over the Edge" where her name would be listed as one of the participants.

On behalf of herself and the Board, Freeholder Hayes recognized Ocean City Intermediate School Principal, Jeff Haines for being chosen as 2018 Atlanticare Healthy Educator of the Year. (Res. No. 439-18)

4) FREEHOLDER DESIDERIO: The freeholder reported the Cape May County Police Academy had won a National Achievement Award from the National Association of Counties (NACO) in the category of Criminal Justice and Public Safety for the program "Updating the County Police Academy to Meet the Needs of a Changing Law Enforcement Environment". This is a prime example of multiple departments working together to achieve a goal, he commented. The driving simulator and indoor range were highlighted in the submitted application. Diane Wieland, Director, Department of Tourism and Chief Tom DePaul, Director, Public Safety and others worked together compiling the information for the application. Chief DePaul credited the continuing success of the Academy to the support given by the Freeholder Board and the working relationships with the Prosecutor's Office, Sheriff's Department, Facilities & Services, Information Technology, Treasurer's, Human Resources, Purchasing and Administration.

Freeholder Desiderio presented a donation to the county, on behalf of a Sea Isle City family owned business; the same family who also sponsored the Polar Bear Plunge Run/Walk for Autism each year, the Monichetti's of Mike's Seafood, Sea Isle City. A check in the amount of \$5,000 was given by Mike and Ginny Monchetti towards the upcoming County Park & Zoo *Dreamnight* event. *Dreamnight*, an international event for the benefit of disabled and chronically ill children, allowed the kids to explore the park and zoo at their own pace, learning about the animals and exhibits, during a time the facility was closed to the general public, he explained.

5) FREEHOLDER THORNTON: Freeholder Director Thornton reported his attendance at the May department head meeting, the CMC Wellness Division *Lunch and Learn* presentation with endocrinologist, Dr. Christopher Zitnay, annual Armed Forces Day held in Cape May Point, and the monthly Southern New Jersey Freeholder Association (SNJFA) Meeting.

He spoke in his role as President of the SNJFA, last evening, regarding the County's Wellness Program, which had won a national award recently, being recognized for the implementation of components into the program that produced results. We've seen some significant change in our medical experience since this happened he stated. Good job by all those who have participated in that, he added.

Additionally, a resolution was passed at the SNJFA Meeting last night opposing the State Legislature sponsored bill, changing the board name from "County Freeholders" to "County Commissioners", he informed. The New Jersey Association of Counties (NJAC) also opposed the name change. We simply don't want a name change, he stated. Freeholder Morey questioned the reasons given by the legislature for the proposition. It was an antiquated term, no longer relevant, according to the state, was the Director's response.

He reminded everyone of the Memorial Day Ceremony at 2:00 p.m. at the Veteran's Cemetery. Freeholder Pierson and Thornton were to take part in the Wildwood Memorial Day Parade on Saturday and were also chosen to judge the VFW Parade, held in June.

The freeholder commended Rita Fulginiti, County Clerk for implementation of the Veterans and Gold Star Families discount card program in her office. Freeholder Morey asked if businesses were welcome to join the program at any point in the year.
