REPORTS:

- 1) COUNTY ENGINEER: Dale Foster gave a short report on the status of road projects. The paving on Beach Avenue in the City of Cape May between Perry and Ocean Street was postponed until Monday, June 18, due to rainy weather conditions. The reconstruction of Bayshore Road between Wilde and Weber Avenue in Villas, Lower Township was finished last week. Some maintenance paving on Fulling Mill Road was also started, but on hold, until the LTMUA finished a water main extension project on the east side of Villas. Roosevelt Boulevard, between Rt. 9 and the Garden State Parkway was paved and striped last Wednesday and Thursday night. Paving operations will begin tomorrow on Corsons Tavern Road between Gracetown Road and Main Street in South Seaville. Recoating of the bridge railing on the Great Channel Bridge at the south end of Stone Harbor was finished this week. Both lanes on the 17th Street Bridge in Ocean City are expected to open by the end of next week. The contractor will be cleaning up and getting out of there before the end of the month; returning in the fall to do the final restoration. Courthouse-South Dennis Road will have various sections paved next week on Monday and Tuesday. Also on Monday and Tuesday portions of Tuckahoe/Mt. Pleasant Road in Upper Township will have sections paved. Townsends Inlet Bridge Rehabilitation Project has closed down now for the summer season.
- 2) COUNTY COUNSEL: Jeffrey Lindsay had no report.
- 3) COUNTY TREASURER: Francine Springer had no report.

FREEHOLDER REPORTS:

1) FREEHOLDER MOREY: Freeholder Morey saw the dedication of Byrne Plaza on Pacific Avenue in Wildwood on Saturday, June 2nd. It was a nice event and great example of collaboration and great energy coming from Open Space towards downtown improvements, he stated. He also attended a free concert given by the U.S. Coast Guard Band on Friday, June 8 at the Lower Township High School Auditorium. The arena was filled to 90-95% capacity and the performance was well received.

He commented on Res. No. 481-18 authorizing Shared Services/ Project Management Agreement between the County and the Atlantic County Improvement Authority (ACIA). A lot of outstanding work done by the county staff and team to put the agreement together for the benefit of a project at the Airport. There would be much work ahead, but he felt the Board had made a really good decision in choosing the ACIA to work with the County on the project.

2) FREEHOLDER PIERSON: Freeholder Pierson reported the Dept. of Aging and Disability Services sponsored a Services Outreach Assistance & Referral in Lower Township at the Senior Community Center recently. There was a good turnout of county employees and veterans. The local Social Security Administration office also participated.

He attended the Atlantic County Community College dedication of the Veterans Wing at the Main Campus in Mays Landing. It was an excellent event, really well done, he stated.

For Memorial Day, the freeholder had been invited to several ceremonies to speak. He gave a speech in Avalon in the morning. The County also had its own ceremony at the Veterans Cemetery later in the day, he mentioned.

Freeholders Thornton, Hayes, and Pierson attended the Annual Bay Sea District Fellowship Dinner & Eagle Scout Recognition in Vineland. Being able to give out the awards to many senior persons active in scouting, as well as the scouts themselves, made it a fun night he stated.

On June 6th a reception acknowledging the artists that participated in the 2018 Senior Art Show sponsored by the Division of Aging & Disability Services was held at Atlantic Cape Community College in CMCH. Freeholder Pierson gave kudos to Evelyn Todd of the Veterans Bureau for her coordination of the event.

Both Freeholders Pierson and Thornton met with other principals to work on this year's Veterans Day Commemoration. The plan was to hold the ceremony at the Naval Air Station Wildwood again this year.

He acknowledged Freeholder Hayes for the great 40th Anniversary Celebration event at the Park & Zoo on Saturday.

3) FREEHOLDER DESIDERIO: Freeholder Desiderio reported Director Thornton and himself, had visited the new Emergency Management Central Dispatch in Lower Township. He commended both OEM Director Pagliuighi and Director Thornton for the foresight. The facility was amazing, he remarked. All the municipalities should take the opportunity to visit, once they're really up and running because it's something special.

On Friday, he spoke, and gave the Oath of Office to 40 new full-time police officers from around the State of New Jersey, that had graduated from the Cape May County Police Academy. The graduation ceremony was held in the Ocean City High School Auditorium.

4) FREEHOLDER THORNTON: Director Thornton informed his colleagues of participation/attendance at the following events: Cape May County Memorial Day Ceremony, dedication of Byrne Plaza in Wildwood, Cape May County

Community Emergency Response Team (CERT) graduation, 40th Anniversary of the Park & Zoo, Veterans Day planning session, tour OEM Central Dispatch Headquarters in Lower Township, and American Legion Convention in Wildwood.

Cape May County Tourism collaborated and worked together with the municipalities, prompting Director Thornton to share some distinctive designations awarded the beach towns. City of Cape May was voted as one of the Top Best Budget Friendly Beach Destinations by *Readers Digest* Magazine. Wildwood was named as the Best Beach in New Jersey by *USA Today*. Additionally, Ocean City was named as the Happiest Seaside Town by *Coastal Living* Magazine he reported.

Diane Wieland, Director of Tourism and her staff were acknowledged for the New Jersey Tourism Excellence Award for Public Relations Campaign awarded Cape May County, for content featured on the Travel Channel. Episodes were filmed last year, airing this year, he informed.
