COMMUNICATIONS: None.

REPORTS:

1) COUNTY ENGINEER: Bob Church reported on the status of various projects out of the Public Works Department. The Townsends Inlet Project was underway. Physical construction hadn't actually begun, but on September 17th demolition would take place, closing the bridge. Many submittals had come in and a lot of the leg work was getting done up front, he stated. A construction meeting, the first, would take place tomorrow to discuss the schedule and try to keep things on track. Corson Tavern Road was substantially completed, as of August 21st. In Woodbine, the area in front of the school, Webster Avenue was scheduled to be paved from Washington to Heilprin Avenues either Friday or Saturday, with a second layer going down to top it off, the week following. Maintenance paving would resume mid-September, probably starting on Fulling Mill Rd. in Lower Township and Bay Avenue on Dias Creek Rd. This should take care of some of those problem areas he stated. Approximately 40 locations throughout the county had been identified for work under the maintenance drainage contract starting September 4th and ongoing through the fall, winter and spring, on an as needed basis. Last week, the Ocean Drive Concept Development Study meeting, sponsored bv the South Jersey Planning Organization (SJTPO) for the replacement of the Mill Creek, Upper Thorofare and Middle Thorofare Bridges, was held. Baker Engineers in conjunction with WSP provided eight different alternatives of bridge replacements and alignments. One would be to rehabilitate Middle Thorofare Bridge, he informed. Other options were to install a dual bascule draw bridge or a fixed concrete structure, and he explained the differences between the types.

There had been several public and local official meetings on this with everybody giving input. A preferred option matrix was being put together. An interagency meeting in Trenton would take place next with all regulatory authority present, (DEP, Army Corp. of Engineers, Coast Guard, and Fish & Wildlife). Based on that meeting and input from regulators, a single preferred option would be chosen. A meeting to work on funding sources for the bridge was to be scheduled.

- 2) COUNTY COUNSEL: Jeffrey Lindsay had no report.
- 3) COUNTY TREASURER: Lisa Burkhead, Assistant County Treasurer had no report.

FREEHOLDER REPORTS:

1) FREEHOLDER MOREY: Mr. Morey reminded the UAS Symposium would take place September 24 -25, 2018 in City of Cape May at Convention Hall.

He announced the Defense Logistics Agency (DLA) received their authorization through the command and were still hoping to do their demonstration flight in Cape May County in October. Another exercise was planned in October as well for emergency management and more information on both would follow.

Notification came today from the USEDA that the multi-tenant building construction, Tech Village Project, had been awarded \$3 million dollars, which represented nearly fifty percent of the project cost he informed. He thanked Leslie Gimeno, Carole Mattessich, Mike Zumpino, Lou Joyce and others for the great effort.

On the Middle Thorofare Bridge, he acknowledged how really important it was that the County jump into the financing aspects. It's great that we reinvigorated the study he stated. We'll talk to the regulatory agencies and get an alignment established but we need to get aid for the finances to get this done. We don't want this to be a 100% County financed project obviously he further stated.

2) FREEHOLDER PIERSON: Mr. Pierson attended the Cape May County Chamber of Commerce Annual Legislative Update sponsored by Comcast on Thursday August 16 at Icona, Avalon with Assemblymen Bob Andrzejcak and Bruce Land.

He attended a certificate presentation for Edward Weber, a 100 year old World War II Veteran. This was done in collaboration with Angelic Health Services. They had reached out to him and requested a certificate, so Mr. Pierson went down there to visit with the gentleman. The event was taped and aired on South Jersey News and appeared in the Cape May County Herald. He was going to work with various Veterans Organizations within the county to get the word out, the need for volunteers for the Veteran-to-Veteran Visit Program that goes into the homes of Veterans receiving hospice care. They need someone to talk to, they want to talk about their experiences.

Mr. Pierson was planning to present a certificate to another veteran, 98-year old Alfred Shehab, when his schedule permitted.

The freeholder was working on a project with Atlantic City currently. They had requested his help because of his military background. They were hoping to do a Veterans Program for Veterans Day and celebrate their World War I monument at the south end of Atlantic City in the park. They also asked for an hour-long presentation to A.C.C.C. students on World War I, National Guard Units from New Jersey.

He presented several certificates at a Court of Honor for an Eagle Scout, Rolando Camargo of Troop 32 of Ocean City. It was great event and experience for him and his troop he stated. Long time Eagle Scout and World War II through Vietnam Era Veteran, 96-year old Rocky Gannon from Ocean City High School was the keynote speaker at the ceremony.

3) FREEHOLDER HAYES: Freeholder Hayes recognized the County Libraries, which she really loved to do, she explained, whenever she had the opportunity to talk about the things that go on there, because of all the times she heard people remark that we really don't need libraries anymore because they could go on-line and find whatever they were seeking. She read a summary of a letter of praise for the programs and opportunities offered, from a library patron, Cynthia King who attended the Qui gong and Tai gong classes at the Lower Township Branch of the library. After regularly attending the classes for 6 months, Ms. King experienced positive improvement of some health conditions she suffered and was now a believer of the healing power of both. The classes were also great for social isolation experienced by the senior population, she had also indicated in her letter to the freeholder.

On Sunday, the freeholder met with the Women's Resource group down on the beach to witness a plane flying from Cape May to Ocean City announcing the 98th Anniversary of the Women's Right to Vote.

- 4) FREEHOLDER DESIDERIO: Freeholder Desiderio had no report. As a follow-up to the report give during the caucus, he questioned Engineer Bob Church whether the railing project would be completed during the time the other work was being performed on the Townsend's Inlet Bridge. Mr. Church responded the railing project was being worked on the other side presently and a submarine cable was being done. There were three projects now ongoing he stated.
- 5) FREEHOLDER THORNTON: Director Thornton reported he and Freeholder Desiderio recently met with the Attorney General and Assistant Attorney General. In house, administration had been interviewing the staff for the CFO position. Additionally, he had been working with Freeholder Pierson and Donna Groome, Human Services, Division of Social Services Director, on Code Blue, considering some new ways to address the issue.

Clerk of the Board read Bond Ordinance 3-18 by title:

Bond Ordinance amending and supplementing Bond Ordinance 1-13 (which provides for various improvement or purposes) heretofore finally adopted by the Board of Chosen Freeholders of the County of Cape May, State of New Jersey on December 27, 2013, to amend the description set forth therein.

BE IT ORDAINED AND ENACTED BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF CAPE MAY, STATE OF NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

SECTION 1. Section 3(d) of Bond Ordinance Number 1-13 finally adopted on December 27, 2013 by the County of Cape May, State of New Jersey (the "County") entitled, "BOND ORDINANCE APPROPRIATING \$47,500,000, AND AUTHORIZING

THE ISSUANCE OF \$44,377,700 BONDS OR NOTES OF THE COUNTY, FOR VARIOUS IMPROVEMENTS OR PURPOSES AUTHORIZED TO BE UNDERTAKEN BY THE COUNTY OF CAPE MAY, NEW JERSEY" (the "Original Ordinance"), is hereby amended and supplemented, as follows:

"Section 3. (d) Improvement of County-owned properties and facilities in, by and/or for the County by the improvement, renovation, upgrade and/or reconstruction thereof, including without limitation, the Crest Haven Nursing Home by the upgrade of the piping thereat; the Cape May Airport by the acquisition and installation, as applicable, of piping for an above-ground diesel tank and any associated and necessary improvements concerning said tank; the Courthouse by the renovations thereof and the construction of additional offices and storage facilities; the upgrade to the dewatering pad; the upgrade of the fuel facility; the upgrade of the salt storage facility; Dennis Township and Woodbine Schools by the installation of new generators; the County Technical School by improvement of the athletic fields; and renovations to Atlantic County Community College, including also the hazard mitigation project and environmental cleanup at various locations and the upgrade of the stormwater and sewer pumps, together with all structures, equipment, site work, work and materials necessary therefor or incidental thereto, all as shown on and in accordance with the plans and specifications therefor on file or to be filed in the office of the Clerk of the Board of Chosen Freeholders or the County Treasurer and hereby approved."

SECTION 2. Except as expressly amended and supplemented hereby, the Original Ordinance shall remain in full force and effect.

SECTION 3. The County covenants to maintain the exclusion from gross income under Section 103(a) of the Code of the interest on all bonds and notes issued under this ordinance.

SECTION 4. The County hereby declares the intent of the County to issue the bonds or bond anticipation notes in the amount authorized in the Original Ordinance from the date of original adoption thereof and to use the proceeds to pay or reimburse expenditures for the costs of the purposes described in the Original Ordinance. This Section 4 is reiteration of declaration of intent that was undertaken when the Original Ordinance was adopted within the meaning and for purposes of Treasury Regulations §1.150-2 or any successor provisions of federal income tax law.

SECTION 5. The Chief Financial Officer is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document to be distributed in connection with the sale of obligations of the County and to execute such disclosure document on behalf of the County in connection with the Original Ordinance. The Chief Financial Officer is further authorized to enter into the appropriate undertaking to provide secondary market disclosure on behalf of the County pursuant to Rule 15c2-12 of the Securities and Exchange Commission (the "Rule") for the benefit of holders and beneficial owners of obligations of the County

and to amend such undertaking from time to time in connection with any change in law, or interpretation thereof, provided such undertaking is and continues to be, in the opinion of a nationally recognized bond counsel, consistent with the requirements of the Rule. In the event that the County fails to comply with its undertaking, the County shall not be liable for any monetary damages, and the remedy shall be limited to specific performance of the undertaking.

SECTION 6. This bond ordinance shall take effect twenty (20) days after final adoption as provided by the Local Bond Law.
