REPORTS:

1) COUNTY ENGINEER:

Bob Church provided the Board an update to his projects. The Pacific Avenue Road Improvements Stage II would resume on October 3rd, beginning with drainage work. Between now and then the gas company would come in and do offsets and install a new main. That section of road runs from St. Louis to Madison Avenue in Wildwood Crest, he informed.

The Ocean Drive project from 62nd to 80th Street was resuming also. They were doing test pits now and the contractor was expected to start drainage within the next 2 weeks.

At the Airport the government services building work was continuing. The foundations had been completed. Today, the contractor poured one of the first cast in place walls to support the superstructure.

Stagecoach Road and County Route 610 projects would start within the next 2 weeks, he stated. As he had already mentioned, Petersburg Road and CR 610 work would need to be accelerated due to the Christmas house tours that take place every year in December.

Bayshore Road to Fishing Creek Road paving would take place next week for the maintenance paving contract. By the end of the week Stagecoach Road paving should be finished.

2) COMMISSONER PIERSON:

Mr. Pierson commented on the events of the County's Patriot Day Ceremony, which was scheduled to take place on September 11th outside of the William Sturm Administration Building in the Memorial Garden. He stated his appreciation for all the Commissioners and everyone else in attendance. He acknowledged Diane Wieland, Tourism Director, Denis Brown, Public Information Officer, and Facilities and Services staff members for moving the ceremony inside to the Commissioners Meeting Room at the last minute, due to the forecast for rain. The ceremony still went off very well, he noted.

Commissioner Pierson informed the Firemen's Convention would be happening this upcoming weekend in Wildwood. He received a phone call and asked to serve as the Grand Marshal of the Firemen's Parade; he humbly accepted. The parade would be held on Saturday at 2:00 p.m. along New Jersey Avenue, from Cresse Avenue in Wildwood Crest, proceeding north to 26th Avenue in North Wildwood. Give me a wave or throw something at me if you see me out there, he said. He was honored and happy to be given the opportunity, he added.

Ms. Hayes reported the Board of County Commissioners had recently received a letter of gratitude from the Ocean City American Legion Morvay-Miley-Cruice Post 524. She read the letter to the Board, which thanked them for their very generous gift, the CMC Zoo tour, to the Williams family, the 2022 R & R (Rest and Relaxation) family. The R & R Program provided an all-inclusive, one-week vacation stay to a military veteran that recently returned from overseas duty and to their families. The letter from Joe Masington, R & R committee chair credited the county for contributing to another successful year for the program which was going into its' 10th year.

She attended a groundbreaking ceremony for Cape May County Habitat for Humanity. This round, a home was being afforded to a single mother and her son. They would move into their new modular home within the month. The land to put the home down was donated by Upper Township. This might be the tenth home put together and donated by the organization to date, she noted. One more was to be erected across the street from this one.

She attended the 2022 Burke Motor Group Car, Truck & Cycle Show and the Car Show at the Air Station Wildwood. She was amazed how many people have antique and restored cars in the county, she said. She met and spoke with many people at both events.

The Commissioner did a walk through of the Whitesboro Reunion Festival over Labor Day Weekend. Every year this was a nice event, she commented.

She gave an update to the Middle Township AARP, regarding county issues and spoke to the members about available services for the seniors. She did the same county update for the Lower Township Chamber of Commerce while attending the "Municipal Report Month" luncheon.
