COMMUNICATIONS: None.

REPORTS:

1) COUNTY ENGINEER:

Bob Church updated the Board on the status of specific road and bridge projects.

He reported the County had been awarded a \$3.3 million federal grant for the Beach Avenue project in Cape May City. He would issue agreements for the Board's signature at the next scheduled commissioners' meeting. The grant would cover both the construction cost and construction inspection cost.

The emergency repair of the sinkhole at the 104th Street Bridge in Stone Harbor was continuing he said. To date, a diver had re-sheeted three quarters of the west abutment. It was anticipated by Monday new permanent sheeting would be driven behind the abutment. A 30-day completion date was projected.

Stagecoach and Breakwater Roads, part of the maintenance paving contract was finished up over the last two weeks. Remaining work connected to the contract was traffic stripping, rpm work and possible guide rail replacement.

The Ocean Drive and Pacific Avenue Federal Aid projects were ongoing, with both in the second phases of construction. The contractor was currently installing drainage.

MINUTES OF A REGULAR MEETING HELD OCTOBER 11, 2022 (CONTINUED)

In Lower Township, at the CMC Airport, the new Government Services Building was actively under construction. The foundation was now complete, and slab was to be poured shortly. The contractor was on schedule to perform the steel install by mid-November. After that the remainder of the work could be completed out of the winter elements, he said, ending his report.

COMMISSIONER REPORTS:

1) COMMISSIONER MOREY:

Mr. Morey updated the Board regarding the "concept development studies" associated with the County's Comprehensive Bridge Replacement and Improvement Plan. reminded them of the \$1 million grant award coming from the South Jersey Transportation Planning Organization (SJTPO) which assisted with the cost of a concept study for the Middle Thorofare Bridge. Moving forward, it was planned they would next look at the Townsend Inlet Bridge. Lou Donofrio, Commission Engineer had recommended they apply for federal funds available through the USDOT for Bridge Replacement, Rehabilitation, Preservation, Protection, and Construction Program (Bridge Formula Program). The county was awarded \$1.98 million by the program. It would be used towards development studies for the remaining three Ocean Drive bridges, plus the Great Channel Bridge, he explained. From the outset, it was decided the county would fund the concept developments in house, to get the bridge projects started, while looking to federal and state funding for the construction costs. Mr. Church added to the dialogue, informing there was a five-year timeline constraint. Once the agreements were signed off on, the county had five years to complete the "concept development studies".

2) COMMISSIONER HAYES:

The Commissioner informed her colleagues of her participation and/or experience at the following recent events: Townbank Serenity Spa Ribbon Cutting, Palifrova family fundraiser for Ukrainian refugees, Ocean City Crew team invitational races, the Greater Woodbine Chamber of Commerce Swap Meet and Car Show, Upper Township Fall Festival, Coastal Resiliency Conference at Stockton University and the groundbreaking for the new Cape May Library/Community Center & Museum for African American History on site at the old Franklin Street Library.

3) DIRECTOR THORNTON:

Mr. Thornton's reported swearing in the officers for the Greater Wildwood Hotel and Motel Association a few nights ago. They had a large turnout for the installation, he said. He added to Commissioner Hayes' earlier comments about new businesses opening up all around the County. The efforts made were laudable, and success had been achieved due to the businesses, individuals, and municipal Chambers of Commerce working together, he noted.

PUBLIC COMMENTS- Joe McDevitt, Sea Isle City, directed a question to CFO Brittany Smith. Drawing on a topic discussed earlier today at a Zoom meeting between the Cape Issues advocate group and county officials, he asked Ms. Smith to estimate the amount of time it would take to meet her goal to increase the county's balance sheet surplus. In addition, he asked if the county had plans to suspend the collection of the Open Space Fund tax for the next couple of years. Due to the amount of money in the budget line at present, he seemed to infer this action would be warranted.

Jim Chew, Rio Grande, inquired about the status of a request he had submitted at the last Commissioners' meeting. At that time, he asked the Board to authorize a resolution designating the 3rd week of November as Homelessness Awareness Week. He spoke about his intention to represent and support homeless individuals by doing something tangible for them. He again stated his need for local government entities to support his efforts.

Joe McDevitt, Sea Isle City, came forward for a second time, posing a question relative to the County's trust fund. Specifically, he questioned budget document figures for county employee accumulated absences. He wanted to know if the county had ever considered eliminating the practice of paying out employees their banked sick time upon retirement.
