## Uniform Commercial Code Documents

### Uniform Commercial Code (U.C.C.-1) AKA Financing Statement

The purpose is to evidence a security interest in personal property.

#### Requirements – NJSA 12A:9-502, NJSA 46A

1. A cover sheet (or electronic synopsis). The fill in cover sheet form is available at this link:

2. Name(s) and address(es) of debtor(s).
3. Names(s) and address(es) of secured party(ies).
4. Name(s) and address(es) of owner of record, other than debtor (see Part B of form).
5. Date of statement.
6. Description of item(s) being used for collateral.
7. Address in the county where the collateral is located.
8. **Note:** The document is normally presented in triplicate form, original sheet filed with the County Clerk, other copies returned. No signatures are required (*as of July 1, 2001*).

### Uniform Commercial Code – Amendment AKA Financing Statement Amendment

The purpose is to amend the original filed financing statement.

#### Requirements – NJSA 12A:9-502, NJSA 46A

1. A cover sheet (or electronic synopsis). The fill in cover sheet form is available at this link:

2. Name(s) of debtor(s).
3. Names(s) of secured party(ies).
4. Date of amendment.
5. File number and date of original financing statement.
6. Description of amendment.

### Uniform Commercial Code – Assignment AKA Financing Statement Assignment

Public notes that a secured party has assigned his/her interest and rights under the original financing statement.

### Requirements – NJSA 12A:9-502, NJSA 46A

1. A cover sheet (or electronic synopsis). The fill in cover sheet form is available at this link:

2. Name(s) of assignor(s).
3. Names(s) and address(es) of assignee(s).
4. File number and date of original financing statement.

**Note:** A financing statement may be assigned on the original financing statement itself showing the name and address of assignee.

### Uniform Commercial Code – Continuation AKA Financing Statement Continuation

The purpose is to extend the time period of the effectiveness of an originally filed financing statement.

### Requirements – NJSA 12A:9-502, NJSA 46A

1. A cover sheet (or electronic synopsis). The fill in cover sheet form is available at this link:

2. Name(s) of debtor(s).
3. Names(s) of secured party(ies).
4. File number and date of original financing statement.

**Note:** A continuation statement must be filed within 6 months prior to the expiration of the original filed financing statement. Financing statements expire 5 years after the date of initial filing. A Continuation is effective from expiration date of initial filing. The statement is effective for 5 years.

### Uniform Commercial Code - Partial Release AKA Financing Statement Partial Release

The purpose is to release a secured interest in certain items described in the financing statement.

### Requirements – NJSA 12A:9-502, NJSA 46A

1. A cover sheet (or electronic synopsis). The fill in cover sheet form is available at this link:

2. Name(s) of debtor(s).
3. Names(s) of secured party(ies).
4. Description of collateral being released.
5. File number and date of original financing statement.

### Uniform Commercial Code – Termination AKA Financing Statement Termination

When a secured party cancels a security interest described in the original financing statement.

### Requirements – NJSA 12A:9-502, NJSA 46A

1. A cover sheet (or electronic synopsis). The fill in cover sheet form is available at this link: <http://www.capemaycountyclerk.com/DocumentCenter/View/4226>
2. Name(s) of debtor(s).
3. Names(s) of secured party(ies).
4. File number and date of original financing statement.
